1. Grant augmentation of up to \$50,000 to Gum Moon Residence Hall for the period July 1, 2017 – June 30, 2018 making total grant for July 1, 2017 – June 30, 2018 up to \$328,088 and July 1, 2017 – June 30, 2020 up to \$884,263. Grant augmentation funds enhanced family

- resource center activities in the Richmond neighborhood using addback funding from the Department of Children, Youth and their Families.
2. Grant augmentation of up to \$50,000 to Portola Family Connections for the period July 1, 2017 – June 30, 2018 making total grant for July 1, 2017 – June 30, 2020 up to \$1,700,000. Grant augmentation funds enhanced family resource center activities in the Portola neighborhood using addback funding from the Department of Children, Youth and their Families.
  3. Grant augmentation of up to \$60,000 to Instituto Familiar de la Raza for the period July 1, 2017 – June 30, 2020 making annual award \$844,183 and the total grant for July 1, 2017 – June 30, 2020 up to \$2,532,430. Grant augmentation funds enhanced family resource center activities in the Mission neighborhood using funding from First 5 San Francisco.
  4. Grant augmentation of up to \$75,000 per year to Instituto Familiar de la Raza for the period July 1, 2017 – June 30, 2019 making the grant for July 1, 2017 – June 30, 2018 and July 1, 2018 – June 30, 2019 up to \$579,576 and making the total grant for July 1, 2017 – June 30, 2020 up to \$1,663,729. Grant augmentation funds enhanced family resource center activities in the Spanish speaking populations using addback funding from the Department of Children, Youth and their Families

### a. Program Committee report

- Focused on the ASQ and developmental screening
- There are five ASQ pilot sites.
- Commission discussed concerns around follow up and treatment with children in developmental screening high risk area. Some sites do not have the personnel to do follow up and referral.
- Program Committee generalized developmental screening follow up as being an issue but there is still more research to be done. In addition, the committee did a gaps analysis and there was conversation around realistic leveraging points that First 5 could possibly leverage. There are several stages to the ASQ and the developmental screening and a work plan.

### b. Fiscal Committee Report

- Agenda Item IV San Francisco Child Abuse Prevention Center addbacks and Agenda Item V. (b) grant agreements and grant augmentations associated with addbacks approved in fy 17-18 presented and discussed.

- This is not a competitive process. Addbacks are augmented based on the descriptions.
- Staff presented an Inclusion Update.

- Finalize the Kinder Readiness Assessment. Staff is working with OCOF and Applied Research this year on data and mapping.
- San Francisco First 5, OECE, and Department of Public Health are collaborating and rolling out an Early Mental Health RFP by early 2018.
- Staff member Feven Wordofa, 1822 Regional Data Coordinator and Analyst will be relocating to the East Coast. The department is now recruiting for a new 1822 Regional Coordinator Analyst.
