I. ROLL CALL

Commissioner Giraudo called the meeting to order at 4:33 pm.

II. GENERAL PUBLIC COMMENT

There was no general public comment.

Agenda item IV and V, to approve Preschool for All providers and the Consent Calendar, has been moved up on the agenda.

III. Discussion and possible action to approve year 11 (2015-16 transition year) additional Preschool for All providers

Staff presented two new private provider sites for the Preschool for All (PFA) program. The two new sites are Bright Horizons by the University of California San Francisco (UCSF) and the San Francisco State University (SFSU) Children's Campus Preschool. Both of these sites are located in District 7 represented by Supervisor Norman Yee. This will add sixty additional preschool age children to the PFA total. The funding will begin once approved.

A motion to approve the additional two PFA providers was made by Commissioner Su and seconded by Commissioner Merz.

The motion carried unanimously and was approved at 4:37 pm.

a) Review and approval of the November 4, 2015 meeting minutes.

- Staff will review the demographic data before publishing the strategic plan.
- Staff will begin to discuss implementation activities once the plan is approved.
- Staff will provide periodic updates to the Commission of the implementation planning.

A motion to approve the First 5 San Francisco 2016-21 strategic plan was made by Commissioner Merz and seconded by Commissioner Asato.

The motion carried unanimously and was approved at 4:54 pm.
