RFQ	As the proposers apply to qualify for the SF "Training, Technical Assistance, and Rating Assessment Service," do we need to choose only one focus area for a written proposal, or can we write a proposal for all three areas to have flexibility with the service content? Thank you.	Proposers do not need to focus on one Core Area and are allowed to submit proposals for all three Core Areas.
RFQ	Is this opportunity to potentially fund coaches who are employed by an agency and paid in part by DEC? If so, does the agency apply on behalf of the coach?	Yes, this is the opportunity to fund coaches employed by an agency. The agency applies for the RFQ and uses the experience of the coaching staff.
RFQ	As current DEC grantees funded to do Teaching and Technical Assistance, we were curious to see if there would be carry over or focus on CPR/First Aid training/certification. We did not notice this as a focus area within the RFQ.	Yes, this is a possibility under this RFQ
RFQ	Our organization is planning to submit two responses to RFQ #DEC24-04 (one for training and technical assistance services; one for rating assessment services). If we do not offer assessment services this seems as though we would start at a total of 85 possible points rather than 100 possible points.
