## 7. Committee Updates

Patricia Sullivan: Family Child Care Association has been meeting on a monthly basis with an average of 50-160 providers joining. FCCASF members have been using that space to voice concerns within the field.

Abigail Stewart-Kahn: Stanford Center for Early Childhood is doing an evaluation of the Thriving Providers Project which is doing pilot direct cash transfers with family childcare providers so far in Colorado, Philadelphia, New York and then Los Angeles too see if they are effective in supporting the family childcare workforce.

Meredith Dodson: SFUSD is anticipating staffing reductions and school closures, the numbers are not available, and my guess is somewhere in the 15 to 20 realms, there are expected impacts on the community. More information is to come.

## 8. CPAC Report

Monique Guidry:

CPAC Coordinator Melanie Hobson- She will be long-term staying in more of an administrative role. She will be handling CPAC Committees, Membership and Finance. The Executive Committee Members are currently discussing a job description for an additional part time person who will handle more of the outward facing strategic relationships and advocacy.

UPK- CPAC has received funding for round 1 and applied for round 2. Funding round 2 is currently on hold while state budget negotiations are in play. The CPAC website is presently populated with all the content for UPK, and stakeholders can read and access.

Meetings: There is a Full Membership meeting on July 10<sup>th</sup> where Graham from DEC and Liz and Mona from LIIF will be presenting on Facilities. August's meetings will be canceled.

Public Comment:

Amie Latterman w/ Children's Council: Thank you very much for the really robust presentation about the roadmap Director Mezquita. Children's Council is definitely very concerned about the idea that the Board of Supervisors would be limiting DEC ability to bring on new staff and continue to expand and really meet the vision that they have put forward. We will be certainly reaching out to our Board of Supervisors members to encourage them to really allow for flexibility in this case and make an exception, knowing how stretched the wonderful folks at DEC are already, and how hard it has been for you all to hire and really staff up over the last couple of years for reasons out of your control and so I just wanted to put that out there. This this is a big concern for Children's Council. We know that it will hamper our ability, as a system, to meet the needs of our community and really fulfill the voter intent that was behind Baby Prop C.

Sara Hicks-Kilday w/ ECESF: Ditto to what Amy just said, and just an appeal to keep us very informed. To my understanding Chan is not going to oppose program staff, but the upgrade, the administrative position you are asking for, and I have sent 2 very lengthy and eloquent letters already and will continue communicating with Supervisor Chan and other supervisors. It is not part of the bit bigger picture of funds, and it is possible to draw down funds even during the year. If there was a blockage, I hope we can get her to make an exception now. But I do want to be sure and appeal to you to stay in very close communication about exactly how a program is being blocked because we don't have the financial and contract expertise. We need to move it forward quickly. I don't want you dealing with frustrated community and the community to be frustrated. I want to to work together as a great team. So, the more we can exercise the wheel with a having enough staff and make it really spin the better we can get programs out that community has been waiting for. So just wanted to shout out my support and let you know we were here and listening for all the details that might help us best advocate for putting programs out that are needed.

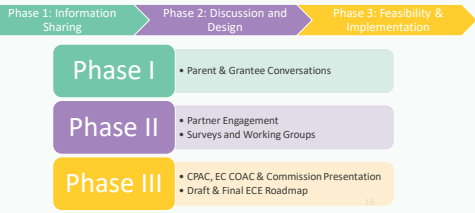
Building 1,600 new spaces with \$117 million allocated from fund balance to focus on infant and toddler care facility expansion.

Je Ton Carey w/ Children's Council: I just had a question around the data. Could it be a matter of who is actually performing the KRI assessment? There is research connected to the fact that there might be some beneficial benefits from having someone that's reflective of the same language or culture. So, I'd be curious on who is actually implementing those KRI assessments in the classroom. The second thing I wanted to

affirm around our Black ECE pipeline. We're in our 4th year. We've had great success and been extremely intentional around who we actually bring into our pipeline and support. It's crucial that everyone understands that we really have been trying to remove barriers to a community that has had extreme disadvantages and part of the work that we do around our pipeline is really supporting that community around all aspects of their wholeness, whether it be their health and wellbeing, whether it be connecting them to houses and resources. And that's not a small feat that's huge because at the end of all of this the hope is that we are securing each teacher for life, learning or a career. Not just a temporary placement in ECE. Again, I want to thank you all for your work and providing this data. I am extremely, extremely excited to see the work ahead. That's happening with DEC, thank you.

Oscar Tang w/ FCCASF: I'm a father of a 3-and-a-half-year-old and with the family childcare community. I want to make the comment on the kindergarten readiness. Our community wants to be supportive of the KRI. To make everyone success. I think everybody want this, too. That's 1 thing I hope to see from the UPK planning that is not happening is coordination. CPAC with everybody together to really get a chance to talk with the school district and find out their challenge. They send us flyers, and some see us a threat. So, it's not as simple as just passing the flyer, there needs to be a relationship. We need to build a trust.

Virginia Taylor w/ Safe and Sound: I am the new senior policy advocate at safe and sound and I just wanted to thank the De C for the enhancement grant money that we received. and I also wanted to thank the commissioners for calling for calling out today the family support agencies and their help in the community readiness, because, as we all know, these the whole family is very important in conjunction with these.

## Historical Investment in Early Educator Compensation

### Early Educator Support Grant

- Educators are receiving **30-47% more in pay**.
- Average Salary **\$29.50 to \$37.00 per hour**, based on teacher role/education.
- Approximately **1,200 early educators** receiving grant funding pay augmentation.

### CARES 3.0

- **\$20 million annually** allocated to fund stipends for wage gaps
- Over **1,600 educators** receive increase in compensation, with an average of **\$12,336**.
- DEC & Office of Economic and Workforce Development Partnership: recruitment of new early educators with a **focus on African American early educators**. Funding efforts total over **\$1.6 million annually**.

## Strategic Facilities Expansion- High Quality Learning Environments

DEC is investing to build new early education facilities. On average, adding **325 spaces annually**, increasing network capacity for 0-3 year olds

Current pipeline: 26 Capital New Development projects, includes 17 in FY24-26 with increased capacity projections of:

- **397 infant-toddler spaces**
- **836 preschool spaces**

## Two Years of Steady Growth & Expanded Access

- Expanded eligibility for free, high-quality early care and education (ECE) to families earning up to **\$158,000 (110% Area Median Income)**
- Reduced the ECE "wait list" of families from **3,061 to 850 (-72%)**
- Increased the number of infants served from **2,020 to 3,111 (+54%)**
- Added **47 new family child care homes (+19%)** and **20 new centers (+13%)** to DEC's network of **469 high-quality ECE programs**
- Awarded more than **\$13 million** in 2022-23 to add over **550 new spaces**

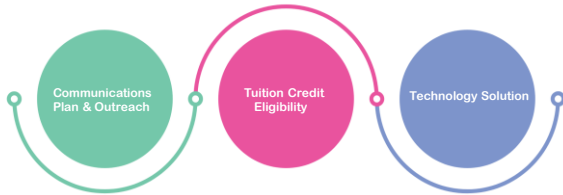
## Early Learning for All

- As of **July 1, 2024**, Early Learning Scholarship (ELS) *Transitioned to Early Learning for All (ELFA)*.
- **Early Learning For All** weaves together ELS and Preschool for All into one fantastic program under DEC.
- Families earning up to **150%** of the Area Median Income (**\$225K** a year for a family of four) are now eligible for financial support!

## Boosting Retention by Enhancing Working Conditions

- The survey is expected to be available from October to December with community engagement review of the data in late summer.

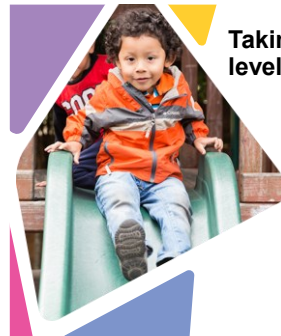

## Building a Movement: Growing, Recruiting, and Sustaining Diverse Early Educator Workforce

- **Stipend for Early Educator Professional Development (SEEPD):**
  - Since May 2024, has awarded \$3.7 million in stipends to over 800 early educators for completing educational units to enhance classroom effectiveness
- **Recruiting and Retaining a Diverse Early Childhood Workforce:**
  - DEC has allocated \$30 million over next four years to recruit new educators and enhance professional growth of early educators.
- **Key pathway strategies include:**
  - Leverage federal apprenticeships – higher education cohorts
  - Student supports for college courses – tutoring, mentorships, childcare
  - Employment readiness upon graduation
  - Career exploration for high school students

## Building a strong early care and education network.

Since we launched the rolling application and validation process, we have onboarded over **150** new programs into the network.

When we receive an application, the program is assigned to a DEC program officer in the order their application was received (**first come, first served.**)

We currently have **50 programs** with program officers assigned and moving through the validation process, which can take up to 6 months.

Once a program is validated and accepted into the network, we are working on implementing a quality monitoring process, to ensure it maintains the **high-quality experience** we aim for every child to have.

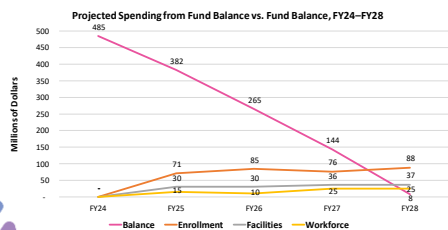

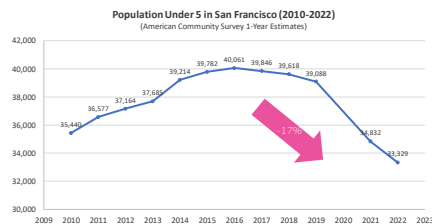

## Current initiatives are projected to spend down the fund balance in the next three years



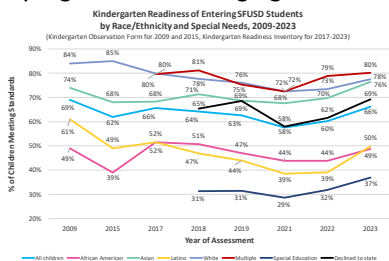

- No change in KRI assessment tool or methods of training and administration
- Literature review of other counties and states found that San Francisco's improvement was an outlier
- Possible explanation: Smaller ECE group sizes and higher adult-child ratios due to DEC policies/actions since March 2020?
