3. General public comment

Janis Connallon w/ Family Services Alliance: I have 2 quick comments for today, as we all know, family support organizations need stable long term city investments.

FRCs and the ECEs have a strong partnership now and we just request that there is a strong investment in services with children and families and ongoing support as we help them navigate systems. Another thing I want to call your attention to is that February 26<sup>th</sup> through March 1st we're having Family Support Services week, and there are several organizations that are opening their doors.

You should receive some information about it. We're hoping that commissioners will come, and it's a really important time to see and fall in love with a really special service delivery that happens for families in these organizations. Thank you.

Rachel Church w/ Parent Voices: I work for Door Dash to support my child. The hours are often long, and throughout the night I have to ask my elderly father to take care of my daughter. He doesn't mind, although he lives on a very simple social security check. It would be nice if he could be paid for his job. Many of our children in San Francisco, in fact, more than half of our children are in licensed exempt care because their schedules do not match that of licensed day childcare. They have made that choice. They feel safer with their babies, being with someone they know and trust. Many of my friends also used family, friend, neighbor, care, when their children were infants, because of the one-on-one care that this type of care can provide. Yet we drop the ball on these providers and forget they exist. We consider them low quality, while the supply of ELS care in the city, especially in Spanish-speaking and English-speaking population does not meet the demand. We need to do something. We need to increase the reimbursement rate for all providers, especially those who do evening and weekend care. Family friend, neighbor care is here to stay. It is a traditional care for many. We need to support their quality development by providing quality workshops in both Spanish and English. Where the demand is really high, incentivize participation in these workshops, please make it available both in person and online. We are asking you to include funding in the budget for increased rates for our Ece workforce and include quality support and incentives for family friend. Neighbor caregivers also create a substitute pool for any and all types of providers who want to attend classes, workshops and webinars. Please provide a stipend for participation in quality trainings alternately please provide voucher payments for substitutes. Once again, I thank you for your time.

Tracey Faulkner w/ Family Resource Center at CCSF: Hi. My name is Tracy Faulkner. I run the Family Resource Center at City College of San Francisco and have been doing so for the last 20 years. Currently student parents. There are 3,000 students, the majority of which are on financial aid. As we know, families are struggling as we come out of the pandemic, especially women. Yet we are told the child care program at City College has been shut down. The Family Research Center does have a license exempt childcare, but it's very small, and it can only serve a few of their families and the need is strong. We need to be able to support our families, to go to city College, to be able to get better jobs. We need to work to make sure we're supporting families. All the family research centers need to be supported. We need to find ways in which we can support parents in getting, into the job market. I'm here to agree with Safe and Sound, and also find ways we can get a childcare for student parents who are at City college, and other ways in which we could support them as they navigate the city college system. Thank you.

Lily Ana Marquez w/Parent Voices: I'm a mother of 2 kids. One of my kids is considered to have special needs and has an IEP right now because he had been struggling since he was a little kid. I've had to be persistent to get him the services that he needs but, on many occasions, it's been hard to get my kids to be watched because of my child with special needs. So, I got a job. at a childcare program and one of the incentives is to have my kids be a part of that program. Unfortunately, a lot of the staff are not equipped to help children with special needs and give them the resources and the child care that they deserve. Having a kid with special needs brings a lot of difficulty. The school district claims they don't have the resources or the people skills to meet all the needs of the different children. So please, I ask you to support these groups of children who are at disadvantaged already compared to other kids. Please increase access to child care services for them especially those with special needs. I strongly believe that all children and their families need a child care that best serves them, and their family's needs. Please consider my difficult situation and life experience, what I go through every day and struggles that I go through with my son. I'm not giving up on him. I strongly believe all children deserve access to good education and quality care. Thank you for hearing my story.

Eleazar Martinez w/ Family Connection Centers: Family organizations, including family resource centers, provide culturally and linguistic responsive trauma informed services for approximately 40,000 parents and children. During the pandemic additional funding became available to support families through FRC's and family service organizations. Some of that funding is no longer available, but the needs of families continue to increase, even though the public health emergency is over. Family support organizations need to reliable city investment to provide

families with basic needs. At Family Connections we hand out diapers to over 120 families with infants a month, over 200 families come to our food pantries, and 20 children and their families join us during our playgroups during each session. 90% of our families are low income, and we are at capacity with our waitlist for many of our programs like case management play groups and our food pantries. Ongoing city investment in Family Connection Centers and other family service organizations is the foundation of community focus systems of care that supports our most marginalized families and help them recover and thrive in San Francisco. Thank you.

Maria Luz Torre w/ Parent Voices: Particularly support student parents at City College. They need childcare. I know they've been struggling there, and we have funding to do this. I just want to share with you a quote that I heard at the Children's Summit that we attended last year: "It says the greatest thing we can do is to bring to fruition the battles we have already won". We have one dedicated source of funding for child care. We need to spend this money for child care and everything that the parents prior to me and staff prior to me, have said, we support that. I particularly want to highlight that families need navigating support for finding appropriate care for their children, especially for children with special needs. Many providers shy away from care for children with special needs so gaps in service availability results in high demand for the limited amount of childcare spots with providers that have appropriate level of training to properly serve this diverse population of children. So, we need to support the providers who take care of these children and also provide navigation supports for the parents who have children with special needs. I also want to highlight the needs of parents working at our care. I know that this often comes in the face of discussion about quality, is family friend, neighbor, care quality care? Again, we heard it said that quality doesn't mean perfection. Often the need of a family means that we have to provide the best care available for them at the right time and often their only choice, especially for those working in the evening.

Elia Fernandez w/ Parent Voices: I have 6 grandkids, 2 of them with special needs. I would love for them to have child care. But the providers we need to have more training to take care of kids especially with special needs. Supporting kids with special needs is very important. All the kids are very smart, but they need special care. And also extending child care slots to serve all children, especially the ones with special needs, because they need more attention. And I just wanted to say to thank you for allowing me to speak.

Lourdes w/ Parent Voices: Child care is very important. I benefited from the service when I was a city college student. I also have a child with special needs. And I really need accommodations and schedules, for the weekends that neighbors and sometimes family members to take care of

my children. While I was taking classes at City College, I was able to transfer to a 4-year university. So, I just wanted to advocate for childcare. We should all have access, especially the immigrant community. Some of them don't qualify because of the immigration status, but we should open the doors to for all of them. So that's why it's so important to invest in our future and our children. Thank you.

Delia Fizpatrick w/ African American Early Childhood Educators: Just wanted to mention that we need to make sure that the numbers behind all of the services that the FRC's are providing to make sure that once the DCYF grants that are funding the FRCs is deployed that they are going to quality programming and we need to have more African American providers in the ELS system. Thank you.

Gladys Soto w/ Parent Voices: I have been a member for a long time. I remember that when, my kids were small and needed childcare, it was a hard time. And, when I think about it, the needs are similar. We have made a lot of progress, with all the advocacy and all the elected officials and community members fighting and agreeing on helping our families. But still we need more. Right now, for example, when you think about kids with disabilities who also happen to have parents who work all hours like, from 11 to whatever, because that's the only time they find a job. It's more complex finding childcare providers who are able to work during the night, and also to provide services for kids with disabilities. So, I just wanted to say that. I thank you for all the work that you are doing right, because I know that some of you, or most of you, are parents also, but at the same time we need to continue fighting for our children and our families. Thank you very much.

Mario Paz w/ Good Samaritan FRC and ECE: Good afternoon, venerable commissioners and directors and staff. I think what you've heard from a lot of this public comment is what we all universally know, and it's accepted and proven is the high quality. Early care and education, comprehensive support. Families are the best opportunities to provide the best opportunities for every child. And I guess what we're saying is, our missions are your missions, and so we really need you to join us and be champions as well with us. We know you fight hard, but San Francisco's faced difficult times before, like we are today, and it's faced booming times, and whether it's a boom time or hard time vulnerable families and children often get left behind, either left behind or service cuts. We ask you to learn from the past and not make the mistake. If we know this is universally proven, it's accepted, and that we will decrease homelessness, decrease crime, and have better public safety when every child is succeeding in the city. So, I just ask you to please join us in our missions. We have a universal mission. Thank you.

Well-funded early education and support for children and families is so critical to our children's success. Benu Chhabra w/ Bay Area Professional Family Childcare Network: I'm a large license family childcare Provider hid in Contra Costa County. I've been in the early childhood field for 35 years. I'm also the president of our Bay Area Professional Family Childcare Network. It's an organization for the family childcare providers and I've been with Parent Voices many times in Oakland, and the state capital as well, and I truly believe you know that the childcare is essential. We are the workforce behind the workforce and we

As you know, family child care providers are the only people who are open, extended hours, and they've been open. We open our own doors late hours and also on the weekends. We know that there are a lot of parents who are going to colleges, and also, they are working after hours. Right? So, they are essential workers. And we are the one who opened our doors during the pandemic, and also provided the care opened our homes for distance learning as well. I thank you so much for you to listening to me. Thank you.




### ECE enrollment is recovering, and the age mix has shifted








# Race and special needs are strong predictors of readiness




